Announcement

Re: Revocation of the Declaration of the Severe Emergency Situation in the Areas of Bangkok; Nonthaburi Province; Muang, Bang Phli, Phra Pradang, Bang Boh and Bang Sao Thong Districts, Samut Prakan Province; Thanyaburi, Lad Lumkaew, Sam Kok, Lam Luk Ka, Khlong Luang Districts, Pathumthani Province; Phutthamonthon District, Nakhon Pathom Province; and Wang Noi, Bang Pa-in, Bang Sai and Lat Bua Luang Districts, Ayutthaya Province, and Related Announcements, Regulations and Directives

Pursuant to the declaration of the severe emergency situation in the areas of Bangkok; Nonthaburi Province; Muang, Bang Phli, Phra Pradang, Bang Boh and Bang Sao Thong Districts, Samut Prakan Province; Thanyaburi, Lad Lumkaew, Sam Kok, Lam Luk Ka, Khlong Luang Districts, Pathumthani Province; Phutthamonthon District, Nakhon Pathom Province; and Wang Noi, Bang Pa-in, Bang Sai and Lat Bua Luang Districts, Ayutthaya Province, dated 12 April B.E. 2552 (2009), to deploy various measures provided for under the Emergency Decree on Public Administration in Emergency Situations, B.E. 2548 (2005) to take control of, prevent and resolve the disturbances which led to disorder in the areas in which such severe emergency situation was declared,

Whereas it now appears that the situation which caused the declaration of the severe emergency situation is such that state authorities and agencies concerned can employ legal measures to take control of, prevent and resolve the problem as normal,

By the power vested under Section 5 paragraph 3 in conjunction with Section 11 paragraph 3 of the Emergency Decree on Public Administration in Emergency Situations, B.E. 2548 (2005), a law which contains certain provisions relating to the restriction of individual rights and freedoms, permissible under Section 29 in conjunction with Sections 32, 33, 34, 36, 38, 41, 43, 45 and 63 of the Constitution of the Kingdom of Thailand through applicable legal provisions, the Prime Minister, therefore, announces as follows:

1. The declaration of the severe emergency situation in the areas of Bangkok; Nonthaburi Province; Muang, Bang Phli, Phra Pradang, Bang Boh and Bang Sao Thong Districts, Samut Prakan Province; Thanyaburi, Lad Lumkaew, Sam Kok, Lam Luk Ka, Khlong Luang Districts, Pathumthani Province; Phutthamonthon District, Nakhon Pathom Province; and Wang Noi, Bang Pa-in, Bang Sai and Lat Bua Luang Districts, Ayutthaya Province, dated 12 April B.E. 2552 (2009) shall be revoked.

2. All related announcements, regulations and directives issued under the Emergency Decree on Public Administration in Emergency Situations, B.E. 2548 (2005), pursuant to the declaration of the severe emergency situation in the areas in which such severe emergency situation was declared shall be terminated.
